SECTION 4) FIRST-AID MEASURES

Inhalation:

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media:

Dry chemical, foam, or carbon dioxide is recommended. Water spray is recommended to cool or protect exposed materials or structures. Carbon dioxide can displace oxygen. Fire-fighting Procedures:

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure:

Keep unnecessary people away; Do not touch or walk through spilled material. Clean up immediately. Evacuate area and ventilate. Flammable/combustible material.

Recommended Equipment:

SECTION 7) HANDLING AND STORAGE

General:

Ventilation Requirements:

Eye Protection:

Skin Protection:

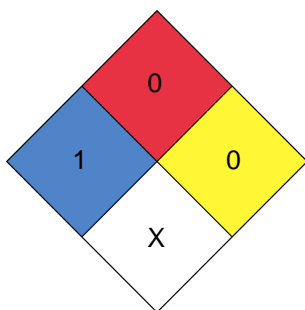
