# **SECTION 4) FIRST-AID MEASURES**

# Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing.

IF exposed or concerned: Get medical advice/attention.

Eliminate all ignition sources if safe to do so.

## **Skin Contact**

# **SECTION 5) FIRE-FIGHTING MEASURES**

# Suitable Extinguishing Media

Dry chemical, foam, or carbon dioxide is recommended. Water spray is recommended to cool or protect exposed materials or structures. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam.

#### Specific Hazards in Case of Fire

# **Emergency Procedure**

#### **Ventilation Requirements**

## 0013463-67-7 TITANIUM DIOXIDE

Is an IARC, NTP or OSHA carcinogen. In a lifetime inhalation test, lung cancers were found in some rats exposed to 250 mg/m3 respirable titanium dust. Analysis of the titanium dioxide concentrations in the rat's lungs showed that the lung clearance mechanism was overwhelmed and that the results at the massive 250 mg/m3 level are not relevant to the workplace. Results of a DuPont epidemiology study showed that employees who had been exposed to Titanium Dioxide were at no greater risk of developing lung cancer than were employees who had not been exposed to Titanium dioxide.
