SECTION 4) FIRST-AID MEASURES

Inhalation:

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media:

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure:

Keep unnecessary people away; Do not touch or walk through spilled material. Clean up immediately. Evacuate area and ventilate. Flammable/combustible material.

Recommended Equipment:

Positive pressure, full-face piece self-contained breathing apparatus (SCBA), or positive pressure supplied air respirator with escape SCBA (NIOSH approved).

Personal Precautions:

General:

Results of a DuPont epidemiology study showed that employees who had been exposed to Titanium Dioxide were at no greater risk of developing lung cancer than were employees who had not been exposed to Titanium dioxide. No pulmonary fibrosis was found in any of the employees and no association was observed between Titanium dioxide exposure and chronic respiratory disease or x-ray abnormalities. 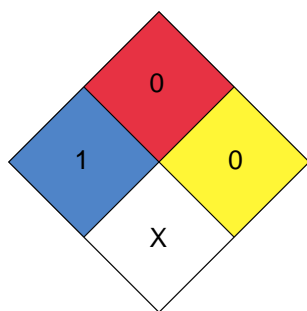
