## SECTION 4) FIRST-AID MEASURES

---

### Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing.

### Suitable Extinguishing Media

### Emergency Procedure

### General

### Eye Protection

### Skin Protection
