Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing.

Skin Contact

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Fire-fighting Procedures

Emergency Procedure

Eye Protection

Skin Protection
