

### DESCRIPTION and USES

**Finisher's Touch Interior Wiping Stain** is designed to produce clear, true colors on wood trim, cabinets, furniture, floors, and paneling. It provides good control of color depth and an easy application.

**Finisher's Touch Interior Wiping Stain** will not raise the grain of the wood and has a sealing action that provides an excellent base for finish coats.

### PREPARATION

**Surface Preparation:** All wood surfaces to be finished must be clean, dry and free of contaminants such as oil or wax. Moisture content of wood should be 7-9%. Sand all rough or previously finished surfaces with 120 - 150 grit sandpaper. Use a tack cloth to insure a dust-free surface. Soft woods may be sealed with **Finisher's Touch Interior Softwood Sealer** for better color uniformity.

### APPLICATION

Stir thoroughly before and occasionally during use. Apply generously with a brush or cloth. Allow to penetrate up to 5 minutes. Wipe off excess in the direction of the grain with a soft, absorbent cloth. **Allow 24 hours dry time before application of finish for best results.** Do not thin this product.

### CLEAN UP

Clean painting tools immediately after use with specified clean up solvent.

### COLORS

A full range of custom colors are available. Use RepcoLite's Alkyd Solvent-borne Color System. Maximum tint load: 12 Fl Oz per gallon.
