

MIRA-POLY Sanding Sealer

DESCRIPTION AND USES

Mira-Poly Sanding Sealer is used after the staining process, before the final finish. The purpose of **Mira-Poly Sanding Sealer** is to provide a high-building, fast-drying, and easy-sanding intermediate clear coat on interior vertical surfaces. It is not recommended for floors or other surfaces subject to heavy wear. **Mira-Poly Sanding Sealer** does not contain zinc stearates so it may be used under urethane varnishes.

SPECIFICATIONS

SURFACE PREPARATION: Sand bare wood with 120 grit sandpaper.

APPLICATION: Apply to bare or previously stained wood with a natural bristle brush, pad applicator, or spray. Allow a minimum of 45 minutes of dry time between coats. Always sand between coats using 180 grit sandpaper. Allow at least two hours of dry time before final coating with **750 Series Mira-Poly Polyurethane Varnish.** Do not use lacquer or shellac as a finish coat.

CLEAN UP: Use paint thinner (Mineral Spirits).
